## SCHOOL-WIDE CHANGE OF MAJOR APPLICATION

This application is to be used if you are an undergraduate Tisch student requesting admission to a different department at Tisch.

### REQUIREMENTS:

Students must be enrolled in the department to which they were originally admitted for one full year before they may transfer to another department.

### IMPORTANT INFORMATION:

If you entered Tisch as a transfer student, your transfer credit from your previous college(s) may not apply towards your new degree requirements or may be applied differently. All transfer credit is subject to the policies and procedures of your new department (e.g. residency requirements and transfer credit maximums.)

### PROCESS:

1. You are required to obtain the signature of your current department chair.
2. All Tisch departments require a creative review.  
Please visit <http://undergraduate.tisch.nyu.edu/page/audition> to check the current guidelines to submit a portfolio or schedule an audition. Auditions should be scheduled by contacting the department as soon as possible. Portfolios should be given to the program of your interest. Please indicate to the department of interest that you are interested in changing your major within Tisch.
3. Please submit a one-page essay indicating why you wish to change your major to another department at Tisch.
4. After you have received the approval of your current department chair, submit this application to: Patricia Decker, Director of Recruitment, Office of Student Affairs, Tisch School of the Arts, 726 Broadway, 2nd Floor, New York, NY 10003

**DEADLINE:**      **Spring: November 1<sup>st</sup>, Fall: March 1<sup>st</sup>.**
